PROGRAM-TO-PROGRAM ARTICULATION AGREEMENT

RATIONALE:

Western Technical College's <u>Early Childhood Education</u> courses provide students with the knowledge and skills essential to their occupational competence as well as develop the foundation needed to live effectively in an ever-changing global society.

Viterbo University's <u>Elementary Education Major</u> (Pre-Kindergarten through Sixth Grade) with a <u>Minor in Early Childhood Education</u> curriculum provides a common background of discourse and educational experience for students.

Due to changing personal and career goals, students enrolled in courses at Viterbo University may choose to seek advanced standing in Early Childhood Education courses at Western Technical College. Likewise, students enrolled in Early Childhood Education courses at Western Technical College may choose to seek advanced standing in Elementary Education with a Minor in Early Childhood at Viterbo University.

This program-to-program articulation agreement affords those students who have completed a baccalaureate degree program at *Viterbo University* or an associate degree at *Western Technical College* the opportunity to transfer to the other institution with advanced standing under the conditions specified below:

- 1. Course equivalencies: Program equivalencies between Western Technical College and Viterbo University are detailed in Appendix A.
- 2. Course Modification: Western Technical College and Viterbo University will notify each other of any course modification(s) which may affect this agreement.
- 3. Grandfather clause: Students who have taken courses at either institution prior to September 1, 2014 and apply for Advanced Standing credit will be granted credit on an individual course-by-course basis, supported by documentation provided by Western Technical College or Viterbo University.
- 4. Course grades: Transfer credits will be granted for Western Technical College or Viterbo University courses in which the transfer student has received a grade of C or better for articulated coursework.

- 5. Challenge exam and Credit for Prior Learning: Students may be eligible to receive additional Advanced Standing credits through the challenge exam or credit for prior learning process as approved by the institutions certifying the candidate's credentials for licensure.
- 6. Transcript record: Western Technical College will record a grade of "CR" (External Transfer Credit) on the student's Western Technical College transcript. The "CR" will not be used to calculate the student's grade point average. Viterbo University will make a transcript entry for transferred course, but will not use transfer credit in grade point average calculations.
- 7. Time Interval: Students must enroll within seven years following completion of an articulated course to receive Advanced Standing Credit(s) under this Articulation Agreement. If the designated time interval has expired, Advanced Standing Credit(s) may be granted by successful completion of a challenge examination or credit for prior learning process as approved by the institutions certifying the candidate's credentials for licensure.
