PROGRAM TO PROGRAM ARTICULATION AGREEMENT

BETWEEN

WISCONSIN TECHNICAL COLLEGE SYSTEM

AND

UNIVERSITY OF WISCONSIN-PARKSIDE (UW-Parkside)

Effective Fall 2016

The purpose of this degree completion agreement is to provide improved transfer opportunities for learners at Wisconsin Technical Colleges who desire further education to enter the University of Wisconsin-Parkside (UW-Parkside). Through the collaborative efforts of faculty, student services, and administration, learners will encounter a clear path to reach their educational goals. Since there are courses that are common to both institutions, a rationale exists to create an agreement for seamless transfer and assist the Wisconsin Technical College student in acquiring a baccalaureate degree at UW-Parkside under conditions listed below.

Learners who successfully complete the following degree:

ASSOCIATE OF APPLIED SCIENCE (A.A.S.) IN

EARLY CHILDHOOD EDUCATION

And who meet the admission requirements of the University of Wisconsin-Parkside and other conditions specified in this agreement will be admitted with up to 69 credits toward a:

BACHELOR OF SCIENCE (B.S.) DEGREE

WITH A MAJOR IN

EARLY CHILDHOOD EDUCATION

PROVISIONS OF THIS AGREEMENT:

1. **Admission and Eligibility.** It is the learner's responsibility to demonstrate fulfillment of the current admission requirements of UW-Parkside at the time of entry. Please note that this 2 + 2 articulation agreement is valid only for students who have successfully completed all A.A.S. degree requirements in Early Childhood and have a minimum cumulative GPA of 2.75 in all courses, a minimum cumulative GPA of 3.0 in Early Childhood courses, and at least a 2.75 in each Early Childhood course. Furthermore, students must maintain a minimum cumulative GPA of 3.0 in all Early Childhood Education courses taken at UW-Parkside in order to complete the B.S. degree with a major in Early Childhood Education. Program to Program transfer courses/credits are accepted only for the degree specified in this agreement.

Admission to UW-Parkside does not guarantee admission to the early childhood educator program in the UW-Parkside Institute of Professional Educator Development. To be eligible to apply for program admission students must meet the following conditions:

- a. Pass the Praxis Core
 - b. Complete Math 102 or 111 and English 101
 - c. Earn a minimum 2.75 cumulative GPA
 - d. Complete all pre-program course work (EDU 100,200,210, 211, 212, WTC 307-148,151, and 167) with a C+ or better in each course
 - e. Complete and pass a certified background check
 - f. Complete two professional co-teaching workshops
2. **About the B.S. with a major in Early Childhood Education at UW-Parkside:** The Bachelor of Science in Early Childhood Education at UW-Parkside is a comprehensive education program that includes a range of essential foundational "core" classes as well as courses in specialized areas pertinent to teaching learning at early childhood developmental levels. The content of the courses in each program is guided by National Standards and Wisconsin Department of Public Instruction standards as well as five integrated themes identified as foundational elements which are embedded in each education course: collaboration with regional partners to support clinical experiences, culturally responsive teaching, reflective practice, civic engagement and empowerment, and the integration of digital technology to enhance teaching and learning.
 3. **Advising.** UW-Parkside and Wisconsin Technical Colleges will provide academic advising to learners inquiring about UW-Parkside programs. Learners will be connected with a UW-Parkside advisor in the Institute of Professional Development prior to transfer. UW-Parkside and Wisconsin Technical Colleges will share materials, catalogs, and other information to facilitate their understanding of requirements and programs. Wisconsin Technical Colleges will assist the UW-Parkside Admission Office and the Institute of Professional Educator Development in arranging recruitment events on its campuses.
 4. **Marketing.** Any marketing of this agreement will be subject to the prior approval of both parties and will adhere to each institution's standards for the use of its name and logo. Each institution will assume responsibility for appropriate marketing to reach its student population. Each institution may provide a link to this agreement and/or the other institution at its website, with notice to the other party.
 5. **Accreditation.** Both parties agree that failure to maintain regional accreditation will be grounds for termination of the agreement. Failure to maintain accreditation required by the specific academic

program(s) referenced in this agreement will be grounds for exclusion of that program from the agreement.

6. **Tracking of Use.** Wisconsin Technical Colleges will provide UW-Parkside Admissions Office and the Institute of Professional Educator Development with the names of students planning to complete the articulation agreement with the intent to transfer to UW-Parkside. This will allow UW-Parkside to plan for the admission, advising and orientation of these transfer students. Wisconsin Technical Colleges also desires to track the use of articulation agreements by students. If possible, UW-Parkside will send Wisconsin Technical Colleges the total number of credits transferred from their institutions annually or other data that can be conveniently produced.

7. **Periodic Review.** Wisconsin Technical Colleges and UW-Parkside will collaboratively review the articulation agreements on a three-year cycle, starting September 1, 2018 or earlier if curricular or institutional policy changes warrant. Each institution agrees to notify the other of significant curricular or policy changes in a timely manner.
 - a. Course equivalencies specified in this articulation agreement are subject to change in the event that the course curriculum of the WTCS Early Childhood Program or UW-Parkside undergoes revision.

8. **Cancellation.** Both parties agree to provide at least one-hundred eighty (180) days' advance written notification of their intent to cancel this agreement. Wisconsin Technical College students who apply to UW-Parkside prior to the cancellation date will be permitted to transfer credits under the agreement terms.

9. **Conditions:** Conditions requested by the receiving institution are listed on the following pages.

The University of Wisconsin-Parkside (UW-Parkside) and Wisconsin Technical Colleges have produced this guide as a tool for students. Every effort is made to maintain accurate information; however, this guide is subject to change. BACHELOR OF SCIENCE (B.S.) DEGREE
EARLY CHILDHOOD EDUCATION

A. General Education and Diversity Requirement:

All students entering UW-Parkside under this articulation agreement will need to meet a diversity course requirement and the General Education requirement of the University in order to complete the B.S. with a major in Early Childhood Education, including: 36 credits from three different departments in each of the follow categories: (12 credits) Humanities and Arts, (12 credits) Social and Behavioral Sciences, and (12 credits) Natural Sciences.

B. Skills Requirements:

Completion of A.A.S. in the Early Childhood program completes the Reading and Writing skills and the Computational skills requirements via the following courses: 801-195 or 801-136 for UW-Parkside's required ENGL 101 and 804-1073 for UW-Parkside's required MATH 102.

C. Foreign Language Requirement:

D. Total Credits and GPA Graduation Requirements







A total of 120 credits is required to graduate with any Bachelor's Degree (B.A. or B.S.), with 30 of the last 60 credits for the degree earned at UW-Parkside as outlined in university policy. All UW-Parkside graduates must have a minimum overall GPA requirement of 2.75 in order to graduate from UW-Parkside. Education majors must have a minimum cumulative 3.0 in all UW-Parkside IPED courses in order to graduate with a B.S. degree in Early Childhood Education. All minimum GPA requirements for completing Education degrees at UW-Parkside will be strictly enforced as they support licensure requirements.






