

Tips for submitting required TB, Immunizations, and CPR Medical Document Manager-ViewPoint Screening

Program students who are required to go to another facility for clinicals/fieldwork/practicum rotations are required to meet and document TB, immunizations (including COVID), and CPR. Western Technical College uses a website called Viewpoint to manage and verify students' records. There is a onetime **fee of \$20** to open your account. It is portable, so once you upload your documents, you'll have access to them from any web browser at home, school, clinical, or work. To open your account, please follow the directions in the Student Instruction document sent to you. Please start collecting your immunizations following the instructions below for each item and then upload the documentation for each to Viewpoint by your due date.

PLEASE READ IMMUNIZATION REQUIREMENTS, THESE DETAILS ARE IMPORTANT

Measles, Mumps & Rubella (MMR)

- 2 vaccinations or a positive titer for Measles, Mumps and Rubella is required.
- If you are unable to obtain your childhood vaccinations from your health provider or clinic, your high school may still have these records.

Varicella (Chicken Pox)

- If you **had** Chicken Pox:
 - **With Documentation.** Documentation **must include your birthdate and the date or age of the occurrence.** Documentation may include any of the following:
 - Medical record from your healthcare provider
 - Letter from your healthcare provider
 - Western Technical College Health Immunization Form signed by your healthcare provider
 - Print out from the Wisconsin Immunization Registry (WIR)
 - **Without Documentation.** You will need to have a positive antibody titer (lab report required) or documentation of two vaccinations to prove you have immunity.
- If you **did not have** Chicken Pox:
 - 2 vaccinations or a positive titer

Hepatitis B: One of the following is required

- 3 vaccination series, you must finish the 3-shot protocol within the specified time frame **OR**
- positive antibody titer (lab report required) **OR**
- A declination waiver form stating that you refuse the vaccine. Contact Jo Duff for the form if needed (duffj@westerntc.edu).

TB Skin Test (Tuberculosis) **READ CAREFULLY**

- Documentation for TB Skin Tests all must be submitted at the same time in one document or they will be rejected.
- **One of the following is required:**
 - **Option 1: Two annual TB skin tests.** Two consecutive annual tests between 10 and 13 months apart.
 - **Options 2: A 2-step TB skin test. 2 Separate Tests are Required Schedule both tests at the same time.**
 - **First test** must be read 48-72 hours after the test is administered.

- **Second test** must be at least 7 days, but no more than 28 days, from when the first test was administered. Must be read 48-72 hours after the test is administered.

– **Option 3: One QuantiFERON Gold Blood Test (Lab report required)**

- **If testing positive, a TB questionnaire is required, a Doctor determines the need for a chest x-ray or signs that you are symptom free, no further TB testing is needed**

Tetanus (DTaP, Td, or Tdap)

- Expires every 10 years.

COVID

- Two COVID-19 Vaccinations (Moderna/Pfizer)
- Johnson and Johnson Single Dose

CPR Certification

- **Only the following CPR certifications will be accepted:**
 - American Heart Association Basic Life Support for the Healthcare Provider Certification
- Western Technical College offers CPR classes throughout the year. Please visit <https://www.westerntc.edu/cpr-and-first-aid> for the current CPR Schedule.
